TO ATHENE ANNUITY:

I understand that, under Section 72(u) of the Internal Revenue Code, a corporation may own an annuity contract and be entitled to tax-deferred status only if certain exceptions apply. Otherwise, the income on the contract shall be treated as ordinary income received or accrued by the owner during the taxable year. I understand that, if the requested annuity does not qualify for an exception under Section 72(u) of the Code, (1) the income on the annuity will NOT be tax deferred, (2) Athene Annuity will not issue a 1099 for the income on the annuity if the owner is a corporation, and (3) the corporation, as owner of the annuity, will be responsible for reporting applicable taxes on the annuity.

I have consulted with my tax advisor regarding the requested annuity. I hereby agree to indemnify and hold Athene Annuity harmless from any adverse tax consequences or other liability that may arise as a result of an incorrect interpretation of Section 72(u).
