#### Accelerated Death Benefit (Included)

Beginning in policy year three, the rider provides for an advance payment of up to 50% of the death benefit if the insured is diagnosed by a physician to have a life expectancy of 12 months or less. Death benefits are reduced by the advance plus interest. This benefit is added at no additional cost.

#### Waiver of Premium Rider (Optional)

Available for ages 20 to 55. There is a 6-month retroactive waiting period.

## Dependent Child Rider (Optional)
